How to Apply

Submit this completed Passenger Information Form with \$1000 deposit check to Andiamo, Box 406, Santa Rosa, CA 95402 by due date. Space is limited; first come, first served. If less than 65 days before departure, email andiamotravel@hotmail.com for last minute availability. Confirmation is sent in writing; your cancelled check is your receipt.

Final Payment

is due 65 days before departure. Custom tours require check payment; sorry, no credit cards. Late payment incur 5% fee.

What is Included

Itinerary-indicated services: select hotels with private bath, meals, transport, sightseeing, admissions, guides/escorts, orientation, reunion and SFO airfare (unless land-only tour).

What is Not Included

Services such as passport/visa fees, liquor, gratuity, options, personal items (phone, laundry, etc) & non-indicated items.

Providers

Changes
